AMEND FY2022/23 BUDGETED POSITIONS

BACKGROUND:

- A. On May 26, 2022, the Sacramento Metropolitan Air Quality Management District Board of Directors (Board) approved the Fiscal Year 2022/23 Budget.
- B. The Board authorizes a schedule of all regular and limited term positions as part of the annual budget process; requests for additional positions or changes must be presented for Board approval.
- C. The state of California has committed to long-term funding of the Assembly Bill 617 (AB617) mandate and therefore two Air Quality Specialist positions working on AB617 programs, one in the Transportation and Climate Change Division and one in the Stationary Sources Division, are requested to be redesignated from limited term to regular status.
- D. An Information Systems Analyst limited term position in the Administrative Services Division was approved by the Board in 2017 to provide needed support during the District's implementation of its Information Technology Systems Integration Project with the intent to determine long-term needs at a later date.
- E. The transformation of technology at the District over the past several years has resulted in an increase in and improved set of tools for District employees and the public to conduct business in a more efficient and effective manner.
- F. The ongoing support of these systems and continued development of new applications/tools, combined with supporting the new hybrid work environment requires this resource for the foreseeable future and therefore it is appropriate to redesignate this position from limited term to regular status.
- G. The three limited term positions identified above are included in the approved Fiscal Year 2022/23 budget and there is no financial impact as pay ranges are the same for limited term and regular status employees within a given classification, and limited term employees are already benefit qualified.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE BOARD OF DIRECTORS RESOLVES AS FOLLOWS:

- Section 1. Effective with the adoption of this resolution, the Fiscal Year 2022/23 Budget is amended to redesignate one Information Systems Analyst in the Administrative Services Division and two limited-term Air Quality Specialist positions, one each in the Transportation and Climate Change Division and Stationary Sources Division, from limited term status to regular status.
- Section 2. The Positions by Classification and Positions by Operating Division schedules in Section 7 Organizational Overview, of the Approved Fiscal Year 22/23 Budget (Exhibit 1) are hereby amended to reflect the changes indicated in Section 1 above.
- Section 3. Exhibit 1 is attached to and incorporated into this Resolution.
