RE: Testimony at the September 27, 2018 Meeting of the Air Resources Board

Dear Senator Dr. Pan:

Thank you for taking the time out of your busy schedule to advocate on behalf of the Sacramento region and the inclusion of the South Sacramento-Florin community in the first year of the new AB 617 community air protection program by the Air Resources Board (ARB). We recognize your willingness to speak with ARB Chair Mary Nichols, your September 18, 2018 letter to Ms. Nichols and the members of the ARB, and the testimony by Ms. Kelly Burns, your District Director, at the ARB meeting on September 27. The Sacramento Metropolitan Air Quality Management District (Sac Metro Air District) is ready to accelerate our on-going community engagement in the region and specifically deploy new air monitoring and other actions in the Florin area as mandated by the adopted statute. This is only an initial step. Thus, we look forward to your on-going support for the growing number of new clean air efforts and the need for cap and trade funding in the Sacramento region.

In particular, we appreciate your willingness to take a leadership role for the Sacramento delegation of state and local elected officials and rally for those in our region who are most impacted by lingering pollution. The South Sacramento-Florin community is the first of 10 different areas in the region that the Sac Metro Air District analysis suggests need new actions under AB 617. We will continue our work with the state to ensure all of our communities in need of cleaner air are considered. The new monitoring information and subsequent measures tailored to mitigate the excess pollution health burden in the south area will benefit the entire region.

We strongly believe that your message at Thursday's ARB hearing set in motion future constructive discussions about the need for other Sacramento communities' air quality emissions reductions and we await the opportunity to work with you and your staff to advocate for additional program funds for other areas in the Sacramento region.

In addition, we are excited about working with you on legislation to examine the contribution by the state workforce to Sacramento's carbon footprint and to explore potential policy options for reductions. As we discussed, Sac Metro Air District staff is the process of conducting an initial first-order analysis to provide you with some initial estimates.

Again, thank you for your leadership on these issues. We look forward to working with you in the years to come as AB 617 opens a new chapter in the fight for clean air for all throughout the entire Sacramento region. The lack of a continuing budget appropriation by the state to fund the AB 617 mandate to air districts means we will be here next year again. Thus, we are eager to strategize with you on the 2019-2020 budget and policy proposals related to AB 617 implementation. I have cc'ed Amy Brown, our legislative advocate, to facilitate a plan moving forward and reach out to you and your staff to coordinate.
