




Community Boundary Discussion: Southwest Corner


- Follows boundary of census tracts

Importance of Air Monitoring (Presentation)

Discuss and prioritize air quality concerns

Discuss and Prioritize Air Quality Concerns

Discuss general air monitoring objectives

Examples of Objectives

Wood Smoke Study:

- Determine impact of wood smoke in EJ versus non-EJ communities
- Differentiate between traffic emissions and wood smoke

Other Examples:

- Determine air quality impact of idling of school buses at schools
- Provide real time community scale air quality information to residents to increase air quality awareness
- Determine the sources of PM concentrations in the community (How much is from stationary sources vs. mobile)
- Determine air quality impact from traffic at major intersections in the community
