Mat was an exceptional APCO, a brilliant engineer, and a very capable golfer among other talents. He will be sorely missed. We encourage you to take a moment of reflection for Mat and the family and colleagues he leaves behind.

The District is currently accepting applications from income-qualified residents in eligible zip codes for grants to replace 2007 or older cars or trucks with a hybrid or electric vehicle. Participants can also choose a pre-loaded transit card from Sacramento Regional Transit to use for their public



transportation needs. This is the Sac Metro Air District's Clean Cars 4 All (CC4A) program and you can help us spread the word; no one knows your community like you!

### **Turning Clean Air Violations Into Community Clean Air Investments** 2021 Supplemental Environmental Projects Awarded

The Sac Metro Air District's Supplemental Environmental Project (SEP) program funds community-based projects using a portion of penalties collected from air quality violations. We are excited to announce our first awardees.



#### Midtown Association - \$85,000

Midtown Association's mission is to make Midtown the center for culture, creativity, and vibrancy in Sacramento's urban core. **Project:** Reduce Midtown Association's carbon footprint by purchasing two electric vehicles, a solar power generator, and converting 53 high-pressure sodium streetlights to LED.



#### 350 Sacramento - \$56,900

350 Sacramento focuses on reducing greenhouse gas emissions and air pollution in the Sacramento region. **Project:** Provide educational materials and host air filter construction events in South and North Sacramento low-income communities. The air filter workshops will help approximately 600 families in the region protect themselves against wildfire and other pollution.

The Supplemental Environmental Project program is a part of the District's contribution to a local strategy to reduce emissions in our underserved communities. Get more information on the <u>program</u>.

## District Makes a SPLASH by Engaging Students in Air Quality and Climate Change Issues

Each year, the Sac Metro Air District participates in a variety of community outreach and educational efforts. Some programs we've hosted so far this year include:

#### **Rio Americano Social Media Contest**

This spring, the District partnered with Rio Americano High School and their Civitas program on a yearlong project to promote projects with positive climate and air quality outcomes. Branded as "Be the Change to Climate Change," students were asked to create a two-to-three-minute video on a topic related to climate and air quality that was important to them.

Led by Isabella Jimenez, a District intern and senior in the Civitas program, student videos were judged by a panel of experts from the District, and prizes were awarded to first (\$500) and second place (\$300). Watch first place winner <u>Joceline Perez's video</u>.

### Splash Sacramento's Youth Environmental Leadership Camp

In June, the District hosted three field trips for 6th- and 7th-grade students participating in Splash Sacramento's Youth Environmental Leadership Camp. Students visited the District's newly renovated Folsom Monitoring Station to tour the station, learn about the equipment and careers at the District, test portable air sensors, and participate in a fun trivia game to test their air quality knowledge.



## District and City of Sacramento Partner to Empower Residents with Air Quality Data

The Sac Metro Air District has partnered with the <u>City of Sacramento</u> on a new <u>portable air</u> <u>monitoring\_project</u> to enhance real-time local air quality information in the City of Sacramento's underserved communities.

The project will deploy portable air sensors that primarily measure particulate matter, empowering residents to adjust their daily outdoor activities and take steps to protect themselves, especially during wildfire smoke events. This project will also enhance air quality data by increasing the number and locations of portable air sensors in more neighborhoods.

The project is supported by a one-time investment from the Sacramento City Council to advance the City's near-term climate action priorities, as outlined in the <u>2021 Climate Implementation Work</u> <u>Plan.</u>

For the first part of the project, which will begin in late summer or early fall, the District will deploy 100 portable sensors in Sacramento. Businesses, residences, and schools will have the opportunity to apply to receive portable air sensors, with priority going to underserved communities.

The second part of the project, slated for this winter, involves innovative block-by-block monitoring, which will provide air monitoring at a finer scale. Street-level monitoring may include air quality instruments equipped on aerial vehicles, on-road vehicles, drones, or other mobile platforms. The goal is to create a dense network of portable sensors that can provide a high-quality representation of pollutant concentrations at the street level. # The Largest Electric School Bus Fleet in North America Just Got Bigger

The Sacramento region has the largest all-electric school bus fleet in North American thanks to the Sac Metro Air District's clean air incentive program . . . and that fleet just got bigger! The Natomas Unified School District has been awarded \$180,000, while the Roseville Joint Union High School District will receive \$400,000, for new EV buses.

The replacement of high-polluting diesel buses with new, zero emission, clean school buses greatly reduces passenger and community exposure to transportation-related air pollution. It also helps school districts with cost savings on fuel, regular maintenance, and repairs. Learn more about the District's <u>school bus replacement program</u>.

### Hydrogen Fuel: Coming Soon to a Station Near You

The Sac Metro Air District is supporting the growing market for hydrogen and hydrogen fueling stations as part of its commitment to move the region towards adopting zero emission vehicles that help reduce greenhouse gas emissions and improve air quality.

When consumed in a fuel cell, hydrogen only emits water and can be produced in a clean manner. This helps improve air quality in our region, especially in communities often impacted by transportation-related emissions.

The District's actions to help bring clean hydrogen to our region include:

- Awarding \$3 million in incentives for hydrogen stations\* in Folsom and South Sacramento
- Awarding over \$4 million in incentives for a heavy-duty truck hydrogen station\* at a soon-to-beannounced location in Sacramento County
- Awarding \$500K towards a hydrogen switcher locomotive and related infrastructure at the Port of Sacramento
- Advocating for hydrogen projects and collaborating with partners across the region
- Exploring additional opportunities for hydrogen production, dispensing, and vehicle use in our region

\* District-funded hydrogen stations are expected to be operational by 2024.





### **Community Celebrates Renovated Folsom Monitoring Station**

In late April, elected officials, their staff, and Folsom residents gathered to celebrate the renovation of the District's Folsom Monitoring Station, a critical capital investment ensuring the Sac Metro Air District's ability to provide the City of Folsom, as well as the larger Sacramento region, with accurate forecasts and

real-time air quality data that helps protect public health, especially during wildfires. The renovation project was a general modernization that included electrical and safety upgrades to meet current building codes as well as additional space for instruments and the site operator.

Media from every major Sacramento television station – KCRA 3/My 58, ABC 10, CBS 13/Good Day Sacramento, Fox 40, and Univision – covered the event. The event included brief remarks from APCO Dr. Ayala and Board Director Aquino before a ribbon-cutting and tours of the facility. In addition to exploring the monitoring station equipment, guests were able to view portable air sensors and review outdoor displays showcasing photos from several phases of the project and real-time air quality data from the station. ### Sacramento Region Air Districts Respond to "F" Air Quality Rating

On May 9, the Sac Metro Air District, Yolo-Solano Air Quality Management District, Placer County Air Pollution Control District, Feather River Air Quality Management District, and El Dorado County Air Quality Management District issued a joint response to the American Lung Association's (ALA) State of The Air Report and the *Sacramento Bee's* coverage of the report on April 22, 2022. The Air Districts addressed the ALA report's ranking of counties based on air quality data that is skewed by extreme but short-term wildfire data and the increasing international transport of pollution that raises background concentrations, resulting in a misleading picture of air pollution emissions in the Sacramento region.

The *Bee's* article omitted these important factors in their coverage of the ALA report as well. In tandem with the joint statement, the Sac Metro Air District also submitted a Letter to the Editor to the *Sacramento Bee* which was published on May 22, 2022. While air quality and public health are absolutely impacted by wildfires, to assign an "F" grade without naming the reason doesn't tell the full story. It also unnecessarily undermines public confidence and denies true progress, which the region has achieved. Thanks to innovative initiatives by the Sac Metro Air District and our regional partners and stringent rules and regulations, air quality in Sacramento (minus the result from wildfires) has improved significantly over the past several decades and will continue to improve.
