Meeting Summary

1. Welcome and Introductions

Co-Lead opened the meeting at 6:14 pm. The interpreter provided interpretation instructions in English and in Spanish. Facilitator reviewed the code of conduct and agenda and Co-Lead conducted roll call for the Steering Committee, Air District, and CARB. Facilitator invited the public to do introductions and share any community events. These are listed below:

Community Events

- Co-Lead announced an Estate Farms Outreach Event at Excelsior Market on May 4, 2025
- Co-Lead also announced a Clean-up and Mother's Day event on May 10, 2025, at Rainbow Main Park, 3890 41st Ave, Sacramento.
- Valley Vision announced a Mobile Monitoring Event put on by CARB and Aclima on May 1, 2025, from 5:30-7:30 pm, at Oak Park Community Center. He noted that food and gift cards will be provided.

2. Administrative Items

2a. Approval of March Meeting Summary

- Approved by Steering Committee vote.

3. Action Items

3a. Vote on Outreach Subcommittee Proposal

Outreach Subcommittee Co-Chair presented the proposal on behalf of the outreach subcommittee. The proposal was requesting Steering Committee approval to purchase outreach materials. Estimated costs were listed at no more than \$1,700. It was noted that there are \$14,200 worth of outreach funds not yet used.

4. Updates

4a. Air District Updates

1. Air Monitoring Location Update – District provided an update on the five potential CSC identified areas for the air monitoring portable lab location and reported that there was a location across the street, north of the Executive Airport, near a current priority location, that is being explored. Air District is working on seeing if we can get electricity to that new location. Questions were posed about cost by CSC members.

2. 2025 Air Monitoring Report

- The Air Monitoring Report was released today. It can be found on the District website under Community Air Protection, Community Air Monitoring. This report includes Phase 1 and 2 data.

3. EPA Mobile Toxics Report

- District announced that the Report for the EPA grant has been completed and posted on the District's website.
- District announced that the District would like to host a community meeting to talk about the data, specifically. They will discuss this with the Steering Committee members.

4. Uber Program

- The District has organized a program to facilitate getting steering committee members to and from in-person steering committee meetings. The District expressed its hope to roll out the program for the June 2 meeting.

5. Steering Committee Membership

- District announced that an acceptance letter was sent to youth applicant. There were various permissions that were required. The District is currently waiting for some final paperwork.

4b. CARB Updates

1. Story Map - CARB Staff shared that they are updating and creating StoryMaps to share progress on AB 617 implementation. The CARB Board briefing is scheduled for July 24, 2025, and will include the StoryMaps, panel discussion with community members that are part of the AB 617 program, achievements, challenges, and successes. CARB Staff are requesting feedback, suggested improvements, and guidance on the Story Map from Steering Committee members. There is a google survey that will be shared with Steering Committee members to solicit feedback.
