Introductions

Announcements

Announcements were moved to the introduction section of the meeting

- Bill Knowlton has resigned from the Steering Committee.
- Laurie Walker and Roberto Rizo are new members of the Steering Committee.
- National Night Out event on August 6th at Shasta Community Park from 6-8pm.
- Two trucking projects have come before the South Sacramento Community Planning Advisory Council recently and the information will be emailed to the Steering Committee.

Administrative Items

Actions:

- Approved June 2024 meeting minutes.
 - Laurie Walker and Roberto Rizo abstained as new members that were not present at the last meeting as a Steering Committee member.
 - Richard Lincoln abstained from voting because he was not present at the last meeting.

Action Items

<u>1. CAMP-CERP (Community Air Monitoring Plan-Community Emissions Reduction Program)</u> <u>Boundary</u>

Discussion:

- Clarifying comments were provided on the bus tour on June 4th, 2024 regarding facilities that were identified on the tour but were not currently active, as well as some active facilities and projects that were not mentioned on the tour.
- It was suggested that in the future the bus has more leg room for seating.
- Discussed public feedback received at events. Clarified that feedback from the public was based upon the new proposed boundaries.
- Discussed why the area is expanding to a larger area.
- It was discussed how much funding is available for the CAMP and CERP.
- It was clarified that boundaries could be adjusted again in the future.
- It was clarified that funding is not based on the size of the community.
- Discussed future monitoring focusing on new areas since monitoring has already been completed in the initial boundary.

Public Comments:

- There was concern voiced regarding the most marginalized communities not being included in the original CAMP.
- There was concern voiced about PM₁₀ levels in the community.
- It was recommended that there is a separate Steering Committee for the CAMP and another for the CERP.
- It was recommended that there is more community involvement and engagement in monitor siting.
- There was support voiced for expanding the CAMP and CERP boundary together.
- It was recommended that there is a discussion of how to include the communities left out of initial boundaries.
- There was support voiced for boundary expansion and including the Mangan Park neighborhood due to history of lead levels.
- It was recommended that there is increased awareness and education strategies for both zones.

Actions:

• Steering Committee approved CAMP and CERP boundary as the same boundary.

2. Final Boundary Vote

Discussion:

- The Steering Committee member size limits were clarified.
- It was clarified by CARB that there is no legislation that precludes an additional Steering Committee, but it would require a formal request and approval by CARB. It was clarified that other communities run a CAMP and CERP at the same time using subcommittees.



- It was recommended that there is engagement with community leaders in overlooked areas.

Actions:

 Adopted final boundaries for CAMP and CERP. Boundaries are the same as those proposed at the June 4th, 2024 Steering Committee meeting.



3. United Latinos' Request to Borrow AB617 Air Quality Monitors

United Latinos was awarded a U.S. EPA American Rescue Plan Enhanced Air Quality Monitoring Competitive Grant and submitted a request to the Steering Committee to borrow air monitor for their community air monitoring project.

Discussion:

- It was clarified by the District the limitations of future community monitoring based on current funding.
- It was clarified that United Latinos will be running the monitoring instead of District staff.
- It was noted that one of the two monitoring locations is in the newly expanded area.

- It was asked whether data would be made available to the public. *It was clarified that it would be made available to the public.*
- It was asked whether it would take away from the CAMP and CERP resources. It was clarified that the proposal is using 2 of the 6 monitors used in Phase 2. It was clarified that these monitors are not being used currently and there are limited resources to potentially run them in the future.
- It was noted that for the Richmond community the District provided support in addition to the monitors for a monitoring partnership.

Actions:

- Approved request for United Latinos to borrow AB617 air quality monitors.
 - Vincent Valdez abstained from the vote as a representative of United Latinos.
