## Meeting Summary

### **1. Welcome and Introductions**

A Co-Lead opened the meeting at 6:12 pm. The interpreter provided interpretation instructions in English and in Spanish for both online and in-room interpretation. The facilitator reviewed the code of conduct and agenda, and a Co-Lead conducted roll call for the Steering Committee. The facilitator invited the public to share any community events. These are listed below:

#### ***Community Events***

- A Steering Committee member announced Parents Wellness Day and social wellness event hosted by Color the Block on July 26. They will be planting trees onsite and piloting their tree giveaway program at Rainbow Mini Park off Martin Luther King Blvd.
- Valley Vision is hosting a digital equity within AB617 community; event on Wednesday, June 25, from 5:30-7:30pm at the Oak Park Community Center, raffling off Chromebooks and helping community members get enrolled with low-cost internet.
- National Night Out on August 5.
- Climate Justice Festival on September 21 at Cesar Chavez Park in downtown Sacramento, time of day to be determined.

### **2. Updates**

#### ***2a. Outreach Subcommittee Updates***

District Staff gave the following updates, listed below:

- During the Outreach Subcommittee meeting, Valley Vision gave a presentation on the community air grant they received to support the AB 617 Steering Committee. They will give a presentation during the July 28, 2025 Steering Committee meeting on their grant and how it can support the Steering Committee.
- Outreach Strategies – the subcommittee discussed and approved three strategies to move to feasibility phase: promote air quality education in schools, outreach through traditional methods and social media, and build relationships with stakeholders and community members.
- Purchasing logistics – it was noted that materials were approved by the steering committee vote and the relevant leads would go ahead with the purchases.

A Steering Committee member also discussed the request to hire two interns from Los Rios Community College, numerous upcoming events, a clean air day event that is in the planning phase, numerous purchase requests, and a budget restoration for the subcommittee.

#### **4. New Business and Upcoming Meeting Topics**

##### *5a. Virtual Office hours*

- A location for the July 28, 2025 Steering Committee meeting was discussed and Steering Committee members agreed that the meetings should be held within the AB617 community boundaries to remain accessible for community.
- Subcommittee and Steering Committee meetings – a Steering Committee member suggested having all the meetings related to the Steering Committee and subcommittees to be on the same day of each week.
  - A Steering Committee member noted that Tuesdays may conflict with City Council meetings and supports having a consistent day.
  - A Steering Committee member posed that multiple days provide more flexibility for community participation and varying schedules.
  - The Steering Committee reached majority support, but not full consensus, on moving all Steering Committee and subcommittee meetings to Mondays – first, third, and fourth Mondays of each month.
- District Staff gave an update on the timelines for the next few months of CERP development.

#### **6. CERP Team Activities**

##### *6a. Community Development Project Presentation (20 mins)*

- District staff gave a presentation on the Community Development process including oversight of systems, considerations before the building phase such as planning review and environmental review, the decision-making process, and timeline for development.
- Sacramento County staff presented the general development review process and current upcoming long range planning efforts.
- City of Sacramento presented upcoming planning engagement opportunities in Sacramento.
- City of Elk Grove staff discussed upcoming planning engagement opportunities in Elk Grove.

The various agencies discussed opportunities for the Steering Committee to establish planning goals through their CERPS which can then be incorporated into different jurisdictions' land use strategies and plans, as well as ongoing and future opportunities to collaborate.

##### *6b. Air Quality Avengers Assemble Breakout Session*

\* The Air District provided a reminder to CERP team activities for the following groups: urban planning and mobile, residential, commercial, and outreach. The District reviewed timelines noting that we have to start reporting out on strategies in July.
