## 2022 Grant Solicitation Awards

## **Summary**

The Sac Metro Air District had over \$22 million in mobile source incentive funding to improve air quality in Sacramento. This funding was made available through the 2022 Community Air Quality Grant Solicitation and has now been fully allocated.

The application period opened on November 1, 2022, and closed on June 30, 2023. Projects included zeroemission heavy-duty vehicle replacements, school bus replacements, farm equipment replacements, lowcarbon infrastructure installations, and other innovative projects.

Priority was given to projects located in Disadvantaged Communities (DACs), AB 1390 designated areas, projects that promoted zero-emission technology (i.e., electric and hydrogen), and projects that provided swift emission reductions to the community. In addition, small fleets (≤ 10 vehicles) received priority if the application was submitted before December 31, 2022.

Awarded applicants entered into a funding agreement with the Sac Metro Air District. Funding of projects is contingent on program-specific requirements. If the award cannot be negotiated and executed promptly, staff may move funding to other projects. Most agreements have a term of 3-10 years with annual reporting requirements and penalties for non-compliance. Projects not selected for funding will remain on the pending list for future funding opportunities.
