Dear Dr. Cliff:

The Placer County Air Pollution Control District (PCAPCD) Board of Directors held a public hearing and adopted the Sacramento Regional 2015 National Ambient Air Quality Standards 8-Hour Ozone Attainment and Reasonable Further Progress Plan (Plan) on October 12, 2023. This Plan was developed cooperatively by five local air districts within the Sacramento Federal Nonattainment Area (SFNA). It demonstrates that existing federal, state and local control measures and programs in the SFNA will provide enough emission reductions for ozone precursors for the SFNA to attain the federal 2015 ozone standard (0.070 ppm) before the end of 2032. The Plan also provides the future Volatile Organic Compounds (VOC) and Nitrogen Oxides (NOx) emission reductions necessary to meet the reasonable further progress requirements for the 2026 and 2029 milestone years, and the 2032 attainment year.

This Plan is required to be adopted by the Board of Directors from each of five local air districts in the SFNA. The PCAPCD Board has adopted this Plan and has met the requirements of Clean Air Act Section 110(a)(2) which requires reasonable notice and public hearing for the Plan. Enclosed are the PCAPCD's Board Memorandum, signed Board Resolution, Notice of Public Hearing, Proof of Public Hearing Notice Publication, and Notice of Exemption for CEQA purposes. There were no public comments received during the public comment period or during the public hearing for this Plan.

Action Requested:

- 1) Conduct a Public Hearing to consider the adoption of the Sacramento Regional 2015 National Ambient Air Quality Standards 8-Hour Ozone Attainment and Reasonable Further Progress Plan.
- Adopt Resolution #23-18 (Attachment #1), thereby approving the Sacramento Regional 2015 National Ambient Air Quality Standards 8-Hour Ozone Attainment and Reasonable Further Progress Plan, as shown in Resolution #23-18, Exhibit I.
- **Background:** On October 1, 2015, the United States Environmental Protection Agency (U.S. EPA) strengthened the national ambient air quality standards (NAAQS) for ozone 8-hour average to 70 parts per billion (ppb)¹. According to the final area designation published by U.S. EPA on August 3, 2018, the existing Sacramento Federal Nonattainment Area (SFNA) which covers all of Sacramento and Yolo County and portions of El Dorado, Placer, Solano, and Sutter County, is nonattainment with a "moderate" classification and an attainment deadline in August 2024². This attainment deadline was almost one year earlier than the 2008 ozone standard deadline. Consequently, U.S. EPA approved the SFNA air districts' voluntary request on October, 28 2021 that the SFNA be reclassified as "serious" with a new attainment deadline in August 2027³. Later, CARB's photochemical modeling results indicated that the SFNA cannot attain the 2015 standard in 2027 based on the current available local and state control strategies. Accordingly, the SFNA air districts submitted another voluntary request to U.S. EPA on August 5, 2022 to reclassify the SFNA from "serious" to "severe-15", with a new attainment in August 2032.

As a nonattainment area, the SFNA air districts are required to prepare a plan to demonstrate how the SFNA can meet the 2015 ozone standard in 2032. District staff worked cooperatively with the other four SFNA air districts, Sacramento Area Council of Governments (SACOG), and California Air Resources Board (CARB) in the development of the Sacramento Regional 2015 National Ambient Air Quality Standard 8-Hour Ozone Attainment and Reasonable Further Progress Plan (Plan). The Plan is submitted to your Board for review and approval today.

Discussion: The Plan documents how the SFNA will meet Federal Clean Air Act (FCAA) reasonable further progress requirements and demonstrate attainment of the 2015 ozone NAAQS, as required by U.S. EPA's ozone implementation rule for the 2015 ozone NAAQS⁴. This Plan includes an analysis of air quality trends, provides an updated emissions inventory for volatile organic compounds (VOCs) or nitrogen oxides (NOx), sets motor vehicle emissions budgets, demonstrates compliance with vehicle miles traveled emissions offsets and reasonably available control measure requirements, satisfies the reasonable further progress requirements, and documents the photochemical modeling results to support the attainment demonstration and reasonable further progress.

Photochemical modeling results indicate that the combined emission reductions from existing local control measures and regional, state, and federal reduction strategies are sufficient to demonstrate regional attainment by 2032. Accordingly, no new regulatory control measures for VOCs or NOx at the regional and local level are proposed for the Plan adoption.

This Plan demonstrates that the SFNA will reduce emissions to meet FCAA reasonable further progress requirements and attain the 2015 ozone NAAQS of 70 ppb. In summary, the Plan:

- provides the air quality analysis showing a decline in the number of exceedances days per year from 97 days in 2002 down to 34 days in 2021 and a decrease in the design value from a peak of 107 ppb in 2000 down to 82 ppb in 2021 for the past twenty-two years (2000-2021),
- updates the VOC and NOX emissions inventory for 2023, 2026, 2029, and 2032, showing significant declines in mobile source emissions, despite increasing population, vehicle activity, and economic development in the Sacramento region,
- presents photochemical modeling results indicating that the combined reductions from existing local, regional, state, and federal strategies and control measures are sufficient to demonstrate attainment by the end of 2032,
- does not propose any new regulatory VOC or NOX control measures at the regional and local level for adoption,
- sets new transportation conformity emission budgets for VOC and NOx for 2018, 2021 and 2024 based on EMFAC2014 with SACOG modeled vehicle miles traveled (VMT) and speed distributions from the approved 2016 Metropolitan Transportation Plan/Sustainable Community Strategy (MTP/SCS), with a safety margin of 0.5 tons per day of NOx in 2021,
- demonstrates compliance with vehicle miles traveled (VMT) emissions-offset requirements through the analysis of existing transportation control strategies and transportation control measures,
- analyzes and documents the general conformity requirements,
- demonstrates that existing local and state control measures will achieve a combination of VOC and NOX reductions for the milestone years of 2023, 2026, and 2029 to satisfy the reasonable further progress (RFP) requirements,
- commits the amendment of existing architectural coating rule as a contingency measure before the end of May 2024,

- promises future ozone planning efforts, including the preparation of progress (milestone) reports to assess RFP, and
- documents that reasonably available control measures (RACM) would not advance attainment by an additional year (from 2032 to 2031) and are not necessary to meet the RFP requirements.
- **Public Outreach:** A regional workshop was hosted by the Sacramento Metropolitan Air Quality Management District to discuss the SFNA's proposed contingency measure commitments as part of the Plan for the 2015 Ozone NAAQS on July 18, 2023. Furthermore, a public hearing notice for the proposed Plan was published on the District's website and the Auburn Journal on September 9, 2023 (Attachment 2). The Proof of Public Hearing Notice Publication is attached (Attachment 3). The Plan and its appendices can be downloaded from the District's website. No public comments have been received at this time. Any comments received after publication of the Board meeting package will be presented during the public hearing on October 12, 2023.
- **Environmental Review:** This action is exempt from the California Environmental Quality Act (CEQA) pursuant to California Code of Regulations Title 14, Division 6, Chapter 3, §15061(b)(3) (no possibility of a significant adverse effect on the environment) and §15308 (actions taken by regulatory agencies to assure the maintenance, restoration, enhancement, or protection of the environment). See Attachment 4, Notice of Exemption.
- **Fiscal Impacts:** There will be no direct fiscal impact to the District with the adoption of the Sacramento Regional 2015 National Ambient Air Quality Standard 8-Hour Ozone Attainment and Reasonable Further Progress Plan. The adoption commits the District to amend the existing architectural coating rule and evaluate additional potential options for other contingency measures. The resource for these activities will be included in the District's budget process for the timeframes identified for adoption of contingency measures.
- **Recommendation:** Adopt Resolution #23-18, thereby adopting the Sacramento Regional 2015 National Ambient Air Quality Standard 8-Hour Ozone Attainment and Reasonable Further Progress Plan, as shown in Resolution Exhibit I, and directing District staff to submit the Plan and necessary supporting documentation to CARB for submittal to U.S. EPA for inclusion in the State Implementation Plan.

WHEREAS, on October 26, 2015, the U.S. Environmental Protection Agency (U.S. EPA) promulgated the revised National Ambient Air Quality Standard (NAAQS) for ozone with an 8-hour averaging time of 70 parts per billion and determined that attaining the 8-hour ozone standard is necessary in order to protect public health (<u>80 FR 65292</u>); and

WHEREAS, on June 4, 2018, the U.S. EPA classified the Sacramento Federal Nonattainment Area (SFNA) as a moderate nonattainment area based on the SFNA design value using air quality data from 2013 – 2015 (<u>83 FR 25776</u>); and

WHEREAS, the SFNA includes Sacramento and Yolo counties, the western portion of El Dorado and Placer counties, the southern portion of Sutter County, and the northeastern portion of Solano County (<u>83 FR 25776</u>, pages 25788-25789); and

WHEREAS, the SFNA air districts reviewed the more recent ambient air quality data and the preliminary photochemical modeling results and found out both of the data and modeling results did not support the moderate attainment deadline of August 2024; and

WHEREAS, on May 26, 2020, the SFNA air districts submitted a voluntary request to California Air Resources Board (CARB) to reclassify the SFNA from moderate to serious and extend the attainment deadline to August 2027. This request was forwarded by CARB to U.S. EPA and was approved by U.S. EPA on October 28, 2021 (effective November 29, 2021) (<u>86 FR 59648</u>); and

WHEREAS, the CARB assisted the SFNA air districts to review emission inventories and conduct more comprehensive photochemical modeling analysis and concluded that the SFNA cannot attain the 2015 ozone NAAQS by the serious attainment date of August 2027; and

WHEREAS, on August 5, 2022, the SFNA air districts submitted another voluntary request to reclassify the SFNA from serious to severe-15, which will allow the SFNA until August 2033, to demonstrate attainment. The request was forwarded by CARB and is pending action by the U.S. EPA; and

WHEREAS, the U.S. EPA published its Final Rule to Implement the 8-Hour Ozone NAAQS, which requires nonattainment areas classified "Serious and above" to demonstrate Reasonable Further Progress (RFP) toward attainment of the 2015 8-hour ozone standard by conducting a Reasonably Available Control Measures (RACM) analysis, compiling emissions inventories, establishing new motor vehicle emissions budgets, and complying with the timing of State Implementation Plan (SIP) submissions (<u>83 FR 62998</u>); and

WHEREAS, the federal Clean Air Act requires a demonstration that the SFNA will meet the 2015 ozone NAAQS as expeditiously as practicable; and

WHEREAS, the SFNA air districts have prepared the Sacramento Regional 2015 NAAQS 8-Hour Ozone Attainment and Reasonable Further Progress Plan (Plan) to satisfy the attainment and RFP demonstration requirements associated with the severe-15 classification (42 USC §7502 (c) and §7511a); and

WHEREAS, the Plan shows a decline in the number of exceedance days per year and the ozone design value at monitoring sites in the SFNA for the past twenty-two years (2000-2021); and

WHEREAS, the Plan uses a 2017 base year and provides emissions inventory forecasts for

volatile organic compounds (VOC) and nitrogen oxides (NOx), which are ozone precursor pollutants, in 2023, 2026, 2029, and 2032 based on existing control strategies and control measure commitments, and the emission forecasts predict a significant decline in future years; and

WHEREAS, the Plan includes the photochemical modeling conducted by CARB to confirm that existing local air quality control programs with the new statewide control measures are sufficient to demonstrate attainment by the end of 2032. Accordingly, no new local or regional control measures are needed to attain the standard by the attainment year; and

WHEREAS, the Plan provides the RACM analysis to show that estimated emission reductions from potential control measures would be insufficient to advance the attainment date; and

WHEREAS, the Plan sets motor vehicle emissions budgets (MVEBs) for 2023, 2026, 2029, and 2032 that are consistent with the emissions inventory and applicable RFP and attainment requirements (42 USC § 5706); and

WHEREAS, the MVEBs, included as part of this Plan, will be reviewed to determine if the MVEBs are adequate for conformity purposes; and

WHEREAS, the Plan presents that the SFNA is expected to meet the minimum emission reduction targets of 3% per year for RFP demonstration years 2023, 2026, and 2029 and attainment by 2032; and

WHEREAS, the SFNA air districts propose to amend the existing architectural coating rule as contingency measure provisions in the Plan and commit to evaluate additional potential options for additional contingency measures after USEPA finalizes the contingency measures guidance; and

WHEREAS, the Plan has been accomplished to satisfy the reasonable further progress demonstration requirements associated with the "severe-15" classification (42 USC§ 7502 (c) and§ 7511a); and

WHEREAS, the California Environmental Quality Act (CEQA) requires that no project that may have significant adverse environmental impacts be adopted as originally proposed if feasible alternatives or mitigation measures are available to reduce or eliminate such impacts; and

WHEREAS, the SFNA air districts determined that the Plan is exempt from CEQA under California Code of Regulations, title 14, section 15061(b)(3) (the general rule that CEQA only applies to projects which have the potential for causing a significant effect on the environment) and under California Code of Regulations, title 14, section 15308 (actions taken by a regulatory agency to assure the maintenance, restoration, enhancement, or protection of the environment) and the Plan will not result in any potentially significant adverse effects on the environment; and

WHEREAS, on September 9, 2023, the Placer County Air Pollution Control District published a notice of public hearing to invite public comments and provide a 30-day period to submit written comments on the Plan; and

WHEREAS, on October 12, 2023 the Board of Directors of the Placer County Air Pollution Control District held a duly noticed public hearing in order to hear and consider public comment on the Plan in accordance with federal Clean Air Act (42 USC §7410(l)) and 40 CFR 51.102.

NOW THEREFORE BE IT RESOLVED, the Board of Directors of the Placer County Air Pollution Control District adopts the Sacramento Regional 2015 National Ambient Air Quality Standards 8-Hour Ozone Attainment and Reasonable Further Progress Plan, including 2023, 2026, 2029, and 2032 emissions inventories, photochemical modeling results, 2032 attainment demonstration, the contingency measure commitment, the reasonable further progress demonstrations for 2023, 2026, and 2029, the motor vehicle emissions budgets for milestone years 2023, 2026, and 2029 and attainment year 2032; and

BE IT FURTHER RESOLVED, that the Plan adoption meets Federal Clean Air Act Section 110 requirements for state implementation plans (SIPs), and Sections 172, 176, 181, and 182 and 40 CFR Part 51 Subpart CC planning requirements for nonattainment areas; and

BE IT FURTHER RESOLVED, that the Board of Directors of the Placer County Air Pollution Control District determines the Plan is exempt from the California Environmental Quality Act under California Code of Regulations, Title 14, Chapter 3; §15061(b)(3) and §15308; and

BE IT FURTHER RESOLVED, that the Board of Directors of the Placer County Air Pollution Control District directs staff to forward the Sacramento Regional 2015 National Ambient Air Quality Standards 8-Hour Ozone Attainment and Reasonable Further Progress Plan and all necessary supporting documents to CARB for submittal to U.S. EPA as a revision to the California State Implementation Plan to satisfy the requirements of the Clean Air Act.


